4. RIVERWALK RECREATION MONTHLY REPORT – JULY 2026

Mr. Carrasco asked what Mr. Russell had been trespassed for. **Ms. Madrid** stated the incident involved an argument with a staff member who no longer works at the complex. She said, after reviewing the incident, it appeared the former employee instigated the argument.

Lynol Russell stated he was playing basketball, and after the game ended, he became involved in an argument with two players on the court. He said the former employee then intervened and began arguing with him. He stated when he returned the following day, police officers informed him he was trespassed from the property.

Mr. Carrasco asked if there had been a physical altercation. **Mr. Russell** said no.

Ms. Morton asked how Mr. Russell would handle the situation if the same incident occurred today. **Mr. Russell** stated he would and walk away instead of engaging.

Mr. Rook noted the complex serves many children and strives to set a positive example. He said arguing with an employee is strongly discouraged and recommended contacting management if an issue arises with a staff member.

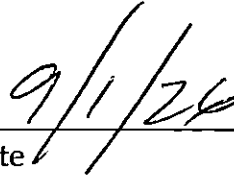
